DRESS CODE IN TEMPLE: Over 300 devotees have been stopped by the management of Shri Mankameshwar temple while entering the sanctum sanctorum of the temple for allegedly flouting the dress code in the past three months.

According to sources, the management of Shri Manka-

300 devotees were stopped while entering into garbha griha for not wearing 'decent' clothes ever since the dress code was implemented, admitted chief priest and Mahant Shridharanand Brahmachari. "The devotees coming to the temple to offer prayers to deities must be conscious about the rich Indian culture and tradition and wear 'decent' clothes while entering and offering prayers to deities at the temple," he added.

He, however, said "The management committee has appealed to devotees that men must wear kurta-dhoti while women be dressed up in saree or suit when they are performing

the temple wearing shorts, jeans, skirts and other 'indecent' clothes. Now, we are forced to stop such people from entering into the sanctum sanctorum." The dress code-cum-guidelines state that those wearing body exposing, provocative, uncultured and indecent clothes are not welcomed in the temple.

The temple management committee has also restricted devotees from clicking photographs and selfies on the temple campus. Thousands of devotees have been visiting the famous Mankameshwar temple to offer prayers to Lord Shiva during the ongoing Shrawan month.
