The dre ss code-cum-guidelines state that those wearing body exposing, provocative, uncultured and indecent clothes are not welcomed in the temple.

The temple management committee has also restricted devotees from clicking photographs and selfles on the temple campus. Thousands of devotees have been visiting the famous Mankameshwar temple to offer prayers to Lord Shiva during the ongoing Shrawan month.
