दिल्ली की तीस हज़ारी कोर्ट में पार्किंग को लेकर हुए विवाद में पुलिस द्वारा वकीलों के बीच हुए संघर्ष में दर्जनों वकील घायल हुए हैं। इस घटना के विरोध में सोमवार को बार कार्डसिल ऑफ इंडिया के आदेश पर जिला न्यायालय फरीदाबाद में वकीलों ने हड़ताल कर दी। हड़ताल के कारण काम के सिलसिले में कोर्ट आने वाले लोगों को परेशानी का सामना करना पड़ा। सैकड़ों वकील सुबह 10 बजे ही लॉबी में कुर्सियां बिछाकर बैठ गए और बार एकता जिन्दाबाद व दिल्ली पुलिस प्रशासन मुर्दाबाद के

नारे लगाते रहे। बार एसोसिएशन फरीदाबाद के जनरल सैक्रेटरी नरेन्द्र पाराशर व सिनियर वाइज प्रेजिडेंट नीरज सचदेवा ने बैठक कर सभी कोर्ट रूमों में हड़ताल की सूचना दी। उल्लेखनीय है कि फरीदाबाद वकील की कार दिल्ली हज़ारी कोर्ट में जेल वैन से टकरा गई थी। इस पर पुलिस ने वकीलों के कारों में प्रवेश ले जाकर कारों को जेल के बाहर नहीं निकाला। पुलिस ने कई सैकड़ों वकीलों को चलाई जाम में एक वकील को गोली लगाई व कई अधिवक्ता शिवदत्त वासिष्ठ ने कहा कि पुलिस ने चैंबरों में जाकर भी
