Finance Commission Submits FY22-26 report to resident

FIANS ■ NEW DELHI

The 15th Finance Commission led by its Chairman NK Singh here on Monday submitted its report for fiscal years 2021-22 to 2025-26 to President Ram Nath Kovind. Commission members Ajay Narayan Jha, Anoo Singh, Ashok Lahiri, and Ramesh Chand, along with panel Secretary Arvind Mehta accompanied the Chairman in the meeting with the President.

Last year, the Commission had submitted its report consisting of recommendations for 2020-21 fiscal, which was accepted by the Union government and tabled in Parliament on January 30, 2020.

As per the terms of reference (ToR), the Commission was mandated to give its rec-

ommendations for the five-year period by October 30. The Commission was asked to give its recommendations on many unique and wide-ranging issues. Apart from the vertical and horizontal transfer of funds, local government grants, local government management grants, the Commission was also asked to examine and recommend performance incentives for states in many areas like power sector, adoption of DPT, solid waste management etc.

The panel was also asked to examine whether a separate mechanism for funding of defence and internal security ought to be set up and, if so, how such a mechanism could be operationalised. The Commission has sought to address all its ToRs in the latest report, organised in four volumes.

Recent farm laws to take agriculture to new heights if implemented in right spirit: Niti member

Asserting that three new agricultural laws legislated by the Centre are in keeping with the changing times, Niti Aayog member Ramesh Chand has said that they are implemented in the right spirit, they will take Indian agriculture to new heights.

In a paper titled 'New Farm Acts: Understanding the Implication', Chand said the reforms have generated optimism for India to become a global power in agriculture and a powerhouse for global food supply. "In a nutshell, the three policy reforms undertaken by the central government through the three new laws are in keeping with the changing times and requirements of farmers and farming. "If they are imple-

mented in the right spirit, they will take Indian agriculture to new heights and usher in the transformation of the rural economy."

On September 27, President Ram Nath Kovind assent to the three Bills — The Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, 2020; The Farmers (Empowerment and Protection) Agreement of Price Assurance and Farm Services Bill, 2020; and the Essential Commodities (Amendment) Bill 2020.

Stating that policy reforms in agriculture continue to be a hot topic in public discourse for the past two decades, Chand said, "The 'business as usual' approach was yielding only incremental changes, whereas the sector needed transformative ones to address agrarian distress."

CAI estimates cotton output for 2020-21 at 356 lakh bales

PTI ■ MUMBAI

The Cotton Association of India (CAI) on Monday projected the total production of cotton at 356 lakh bales for the crop year 2020-21, which is 4 lakh bales less than the year ago period. During the 2019-20 crop year, the total cotton production stood at 360 lakh bales, CAI said in a statement. Crop year begins from October 1. The crop output is estimated to reduce during the current season on account of damage reported to the crop in some pockets due to the excess rains and pink bollworm infestation, CAI added.

Meanwhile, projected cotton supply for 2020-21 crop year stood at 477.50 lakh bales, which consists of the opening stock of 107.50 lakh bales at the beginning of the season, crop for the season estimated at 356 lakh bales and imports estimated at 14 lakh bales.
